It is crucial to familiarize yourself with the contents of these documents, as understanding them empowers you to effectively assert your rights. Knowledge of your rights as a living, breathing individual and as an American is a powerful tool. It is essential that you carry this Traffic Binder with you whenever you are traveling in your automobile, as it serves as your safeguard in ensuring that you are prepared for any situation. Additionally, it's important to be aware that displaying a LICENSE plate on your vehicle signifies that you are engaged in commerce—transporting goods or people from one place to another in exchange for compensation. However, if you are merely traveling for personal reasons, such as going to the grocery store or visiting family, this does not constitute commerce. By removing the LICENSE plate from your automobile, you are effectively placing yourself outside the jurisdiction of maritime/admiralty law, which governs commercial activities involving the movement of cargo. As a living, breathing individual, your actions are governed by common law, as enshrined in the Constitution of the United States of America. Understanding this distinction is vital for maintaining your autonomy and ensuring that your rights are upheld during any encounters with law enforcement while traveling.
