Keep the Peace by Supporting Your Locally Elected Sheriff

The power of your local sheriff outweighs that of state and federal governments. If municipal police, who operate to protect local businesses, are abusing local People then ultimately your local elected sheriff should exercise oversight over the police. Police are for policy enforcement and are not put in place to serve and protect local People. Serving and protecting local People is the duty of your locally elected sheriff.

“... municipal authorities form distinct and independent portions of the supremacy, no more subject, within their respective spheres, to the general authority, than the general authority is subject to them, within its own sphere.”

If law and order cannot be maintained in your locality, it is the duty of your local sheriff to deputize as many local People as necessary in order to maintain the peace. If the local sheriff cannot quail a local insurrection then he should ask for support from state government. If state government will not assist, then an appeal to the federal government should be made.


In cases when the local Republican Form of Government is not upheld because of a general insurrection, as occurred during the *Civil War*, then the President has the expressed Constitutional duty to ensure that local Republican Form of Government is again put in place. This was the intent of President Lincoln. He was able to preserve the union of states but was assassinated before he could fully implement the full restoration of our Republican Form of Government.

The United States shall guarantee to every State in this Union a Republican Form of Government, and shall protect each of them against Invasion; and on Application of the Legislature, or of the Executive (when the Legislature cannot be convened) against domestic Violence.

United States Constitution, Article IV, Section 4

Those involved in the coup against the American People insured that we did not return to our Republican Form of Government by “passing” unlawful legislation such as the Dictionary Act that lowered the status of mankind to that of a corporation and raised the legal status of corporations to that of mankind. They took advantage of the mayhem following the Civil War to change our form of government from the Republican Form of Government to a Corporation ran by a chosen few, in essence, a technocracy ran by an oligarchy. They changed the status of Americans from State Citizens to corporate US citizens. This is what President Washington warned Americans about in his final farewell address.

The People of the free States in Union do not now, nor have we ever supported any intent of overthrowing the UNITED STATES municipal corporation acting as a government. We are not “Sovereign Citizens” as defined by Homeland Security. We are peaceful, non-violent and advocate peaceful, non-violent methods to restore and maintain a lawful, constitutional republican form of governance. We would never advocate or take part in the kidnapping of, or violence against any public official; nor do we affiliate with any hate groups; nor would we participate in any terrorist attack against the U.S. corporate government or any public or private official. We love our fellow man, America, its People and the Republic for which our flag stands. We observe the greatest commandment, namely, that we love God and Love our fellow man. We believe that the rule of law should be applied justly and equally to all, both small and great without regard to race, gender, color, financial status, handicap, or religious affiliation. In short, we believe in treating our fellow man as we would like to be treated. We show tolerance and respect toward corporate law enforcement officers even when those officers, through lack of knowledge, may violate or infringe upon our un-a-lien-able guaranteed liberties. We are not tax protesters or the like. We believe in conducting our commerce and the business of Republic governance in the open, not in secret meetings. We hold that the People intend to research actual Law as well as applicable case Law. We intend on attending as many seminars, meetings and lectures as possible given by law professors, lawyers and the like in order to learn the proper interpretation of law. We are willing to assist any local, state or national leaders, such as presidents, governors, congressmen, senators or representatives in coming to a clearer understanding of their constitutional duties and obligations to the American People.

President James Madison described this type of government in Federalist 39:

“... a handful of tyrannical nobles, exercising their oppressions by a delegation of their powers, might aspire to the rank of republicans, and claim for their government the honorable title of republic...”

Our local sheriffs, of all people, need to

understand our history. It is important that we elect local sheriffs willing to stand up for local People against the technocracy maintained by other “elected” officials. Your local sheriff should ensure that your God Given Unalienable Rights are protected. In no instance should police, court or agency be allowed to abuse the rights of local people within the bounds of a locally elected sheriff.

In addition, if your local sheriff discovers that the rights of local people are being abused it is his duty to take whatever measure(s) necessary to protect those rights. This might include empaneling juries, forming a militia or posse. If you find that the corporation has tried to remove these powers from your local sheriff, then you must act to restore that which has been stolen from your locality. In peacetime, your local sheriff is the only local instrument put in place by our Fore Fathers to maintain the peace and protect your rights. If the authority of the local sheriff has been altered in any way, then your God Given Unalienable Rights are being violated. You must act to restore the powers of the local sheriff and make sure you elect a sheriff who understands our American History.

If your local sheriff fails to perform their duty to protect your God Given Unalienable Rights then the local People, themselves, “the state” must take action to ensure those Rights. We must know, as Americans, that *We the People* are “the state” authority upon the land.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness.--That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, --That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness.
